

### Planning and Zoning Meeting Minutes February 21, 2022

The Planning and Zoning Commission met on Monday, February 21, 2022 at 5:45 pm in Council Chambers located at 200 South Main, Webb City, Missouri.

#### **ROLL CALL:**

MINUTE APPROVAL: Committee Chair, Rick Utter being absent, city manager Carl Francis called the meeting to order. He entertained a motion to approve meeting minutes, January 17, 2022. Mike Moore made motion to approve minutes as written. Melissa Annis seconded. All were in favor, motion carried.

#### **PUBLIC HEARING:**

Mr. Francis opened the public hearing to consider a request to rezone from C-2 (Commercial) to R-1 (Residential), property located at 217 ½ West Daugherty. The rezone request was made by Neil Vanlue. Mr. Vanlue spoke in favor. No one was present in the gallery to speak for or against the rezone request. Mr. Utter called for a motion. Ryan Evitts motioned to approve the request to rezone from C-2 to R-1. Melissa Annis seconded. All were in favor, and none opposed. Motion carried.

#### **PUBLIC HEARING #2:**

Mr. Utter opened the second public hearing to consider a request to vacate a partial alleyway and utility easement to allow consolidation of lots on each side of the alley owned by petitioner Joe Beard, so he could begin construction of single-family houses. Mr. Beard spoke in favor. No one spoke against. Melissa asked Mr. Kreighbaum if any objections had been received by the city during the posting period. Mr. Kreighbaum said there had been only one concerned individual who mistakenly thought it was a different alley. Carl Francis said there are no City utilities in the alley easement, and the alley has never been developed, so the city would be vacating sewer and water easements, but not public utilities if there are any. Melissa Annis made motion to vacate the alleyway. Ryan Evitts seconded. All were in favor, and none opposed. Motion passed.

#### **OTHER BUSINESS**

Mr. Utter asked if there was any other business to consider at this meeting. No one had any other business to introduce.

#### Administrator's Report 02/28/22

Public Works has been working with the Department of Natural Resources to complete both the "Stormwater Annual Report MS-4" for Calendar year 2021 and make application for the next 5 year Missouri Stormwater (MS-4) report and requirements. This report process assures that we remain in compliance with our permit issued under the Small Municipal Separate Storm Water regulations. A full report can be obtained for those interested in the office of the City Clerk.

The **Parks Department will be holding the annual Easter Egg Hunt** in King Jack Park on April 9<sup>th</sup>, 1-3pm. Age groups will be up to 4 years of age starts at 1pm, 4-6 years of age start at 1:30 and then 7 and older begins at 2pm. Children who require special assistance will begin at 2:30pm.

Planning and Zoning, at their 2/21/2022 meeting, approved unanimously the rezone of 217 ½ W. Daugherty former home of Bruce Benson to R-1 from the current C-2 Commercial designation. This request will be presented to council on Monday. This does not include the commercial properties along Main and Liberty, only the residence structure and north lawn.

City staff met with MODOT regarding recent requests for entrances on Madison. MODOT has implemented some distance requirements recently and that has made development much more difficult along the Madison Street commercial area. We will be working towards implementing a shared driveway and entrance requirement as we move forward on any new developments.

The Parks department reports that 340 boys and girls have signed up to participate in our soccer program this spring at King Jack Park. The season March 15<sup>th</sup>, weather permitting. We hope to have the new lighting and fence on the new soccer field (old rodeo grounds) available for play this season.

Sleet and snow moved into the area on Wednesday forcing us to declare a weather emergency at noon on Wednesday and sending all non-essential personnel home. We remained closed on Thursday as the wintry mix continued and ice was forming on the roads again. A few staff came in to handle the agenda and some necessary duties.

The new Stadium View Park playground was delivered to Public Works this week and plans are to have the contractor install the equipment as weather permits. Weather has delayed the start of installing the equipment but will resume at first opportunity.

The new roof was completed on the Farmers Market Kitchen. That should complete all required repairs that had been requested.

Community Development Coordinator Erin Turner has been promoted to the position of Community Development Director and will now be responsible for additional duties within the Parks Department and other activities here in Webb City. One of her additional duties will be to work with the Parks Department to enhance all the festivals and activities to be held in the Parks next year along with operation and management of the sport programs concession stands. Bryan Waggoner will be promoted to Parks Director upon Tom Reeder retiring in May. Together they will assume the duties currently held by the Sporting Coordinator thus eliminating that position.

Work has continued on the city owned property located on Broadway and Daugherty within the Centennial Retail Park. Signs have been placed along East Street and off of Daugherty and Broadway advertising the commercial property available.

City Staff have been working on a **plan to advertise the Centennial Retail Park** and the available retail opportunities within the district. We plan to present a plan at the next Centennial Transportation District Board meeting and possibly use the TDD proceeds and rent a billboard along MO249 and maybe Interstate 49 southbound.

Another great year of the Polar Bear Express has come and gone. This would not be possible without the support of the entire community. Special thanks to those who come out and support the event almost every minute it is running. The Southwest Railroad Association and city staff along with numerous volunteers make Webb City a very special place to enjoy the holidays!

Waste Water crews, in addition to still producing composted soil amendments, have been busy working on a pipe that has been located near the area of 171 and Madison. **This main sized pipe is the old transmission line that we had no knowledge of it still being there.** There is a main line running in a lateral position to it so we can only assume someone did not remove when replacing the pipe. It was located due to the amount of inflow water that was found in the main pipe. Crews will be determining if there are any services still existing within the line and if it can be abandoned.

City staff have met with Olsson Engineering in a meeting to plan the **upcoming storm water study**. Focus will be on possible retention and detention along the west side of the city to try and relieve some water issues within the low lying areas north of 171.

We would like to thank everyone who came out for the **Ribbon Cutting at the new Sleep Inn**. The owner wished that I express his thanks also for such a strong community showing of support. We now have plans and drawings for the next major project which is the new restaurant to sit directly to the north of the new hotel.

The new transmission lines are being installed north of Aylor by Liberty Electric and we have placed an **order to install street lights** upon their completion. We also have requested a couple **new street lights along Pennsylvania near the lakes** to help with that area at night.

Waste Water staff participated in a meeting with the Habitat Management team consisting of trustees from DNR, US Fish and Wildlife and Missouri Department of Conservation. The discussion focused on compost production for next year that will be needed to support the Cardinal Valley Habitat Project. Other topics included long term sustainability regarding future personnel and funding. The current agreement for compost production should carry us through the FY21/22 year.

City Hall staff have been working to update and maintain the Centennial Retail and Industrial District properties in anticipation of the upcoming yearly board meeting. This is no easy task. (I am sure Kim will agree) There have been several properties added and removed during the flurry of activity last year regarding the sale of properties. Each property must have a proxy and petition signed then recorded with the county recorder prior to being added to the Transportation Development District.

#### **SUBJECT:**

The police department is seeking the Council's approval to apply for grant funding from the Missouri Department of Transportation – Highway Safety Division.

#### **BACKGROUND:**

Over the past seventeen years the police department has received \$502,388 in grants from the Division of Highway Safety for DWI Saturation Patrols (Wolfpacks), Hazardous Moving Violation Enforcement (HMV), and enforcement equipment.

This year the police department is applying for funds to conduct DWI Wolfpacks, Speed Enforcement, and Hazardous Moving Violation (HMV) Enforcement, along with funds to purchase equipment to be used during these enforcement activities. The police department may be required to provide up to 50% matching funds. These matching funds would be included in the police department's fiscal year 2021-22 budget.
