Administrator's Report 03/24/2025

Public Works crews have been working on completing the new water main to service the east side of East Street south of Daugherty and also have installed water access at the new "W Club Recreation Facility".

Water Crews have been busy throughout the city lately. They have completed 22 angle valve replacements that were needed and completed 48 meter replacements that were found to be defective in the last week.

The **Fire Department continues to work on their newly built training structure** and the Water Department has now installed the fire hydrant and new line to that facility to be used for training.

As **spring rains are approaching**, public works crews have been working to clear obstructions in our local waterways. Locations have included East Fountain Road, Wood Street and Elliot Street.

Last week's high winds caused several trees to fall and crews were busy Monday and Tuesday cleaning up limbs and debris from our roadways and parks.

Parks Department reports **that soccer season is in full swing** and they have spent time preparing the fields for play. They have also opened the Splash Pad and the adjacent restrooms for the summer.

The new **Dog Park is partially open now** and crews have been busy placing new amenity structures within it and also building the new parking lot adjacent to the facility. If one drives by you can see that the facility is already being welcomed by many.

Parks Department has worked to clean, stock and prepare the baseball and concession stands as the baseball and softball season are coming soon. Along with that they are also working on the upcoming Annual Easter Egg Hunt to be held April 12th in King Jack Park, finalized the playground contract approved by council for Westhaven Park and activated all the fountains in the lakes at King Jack Park.

Community Coordinator has been busy putting together a **new downtown map** to be used for all upcoming events such as the Car Shows, parades and the upcoming **Spring Shop Hop to be held April 5**th **downtown.**

Recently there has been an increase in off road parking on the west side of Powell Drive from Broadway to MO171 hwy. Cars have been pulling down into the ditch up to the property owners fence.

The **contract approved recently by council for the new roofs** to be installed on the Farmers Market Pavilions and the Parks office has been finalized and we should see crews starting work very soon. Farmers Market Board has agreed to donate \$5,000 towards the project.

Previous Meetings

Five leaks have been located and repaired as a result of our recent search along with the company which we hired to search for water leaks. There four broken water lines and one leaking fire hydrant located and marked on the map. Our staff found leaks at each of them and performed the necessary repairs. We plan to continue to utilize their services probably at least yearly.

City staff will be spending time over the next few weeks working to assist with negotiating the new services agreement within the Tri State Health Care Coalition. It has been some time since we have renewed our services contract with Mercy Hospitals and we will try to keep any impact to our service and costs to a minimum.

As spring gets closer we will be gathering locations for the **FY 2025 Paving Overlay** project. Please forward any locations you might wish to have evaluated by staff for possible paving this summer. We will be paving early we hope as soon as we can get the new W Center Recreation Facility parking lot prepped.

Waste Water crews have started moving equipment on site to begin replacing 5 "flush bell" manholes. These are roughly 70 years old and cannot be part of the recent council approved lining project due to their design. The first one is located just west of Madison on Broadway.

Other items of interest with the Public Works staff is they have replaced the guard rail on Prairie Flower south of 171, repaired a large water leak on Arch Street and have started work on the surface for the new parking lot at the "W Center". All this being done while continuing to work on keeping our snow removal equipment ready as weather is expected to come in next week.

Waste Water has received the draft of our new Waste Water Permit from DNR. We have been in process regarding this for a couple years and had feared some drastic changes. Staff were pleasantly surprised to see only a couple minor changes and our wetlands are still safe for at minimum the next 3-5 years.

AN ORDINANCE AMENDING SCHEDULE III, TABLE III-F OF THE WEBB CITY CODE REGARDING NO PARKING ZONES WITHIN THE CITY LIMITS OF WEBB CITY, MISSOURI.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEBB CITY, MISSOURI, AS FOLLOWS:

SECTION 1. As authorized by and in accordance with Section 355.010, it shall be unlawful for the operator of a motor vehicle to stop, stand or park said motor vehicle at any one time or instance or location, as designated herein, except when necessary to avoid a conflict with the directions of a Police Officer or traffic control sign or signal.

SECTION 2. That Schedule III, Table III-F, No-Parking Zones, is hereby amended to include the following street:

Powell, either side:

MacArthur (171) to College.

SECTION 3. This ordinance shall be in full force and effect from and after its date of passage.
