Administrator's Report 03/25/24

The Annual Easter Egg Hunt will be held this weekend the 23rd at 1pm in King Jack Park



Plans are in the works for an indoor recreation center to be located in King Jack Park. We had originally looked at the location near Hall Street and Railroad Way but the amount of fill and dirt work was going to be extensive and the size of the property would limit any future expansion. This location south of the amphitheater and across Dawson Drive has been proposed and since it is certainly more level and larger it would allow future expansions if they became necessary.

Waste Water staff are working with the manhole fabrication company this week and will be relining about 30 manholes here in town. We also will be working to seal up some lift stations and holding tanks. This work was approved last year and we have been waiting for the vendor to arrive. We are confident this is a more efficient method of reducing I&I than complete tear out and replacement.

Staff met with members of the Farmers Market in our monthly meeting. Some of the items discussed were routine maintenance needed in the kitchen and also that the board has decided to curtail private rentals of the kitchen facility. The costs to upkeep the facility and utilities have required the market to utilize the kitchen only for their activities.

In our effort to continually **locate water leaks** public works will be digging in the Mathew Circle area west of the Public Works location for what is believed to be another water leak. We have made significant progress in finding the leaks recently and that is evident by monitoring our run time through the SCADA system installed at our wells.

If you get a chance please drive up East Street and see **the poles that are going up for the new Tee Time Facility**. Exciting to see the progress!

Previous Meetings

Public Works and Waste Water staff will be teaming up in the next few weeks to complete an install of a trash basket system on the East Street lift station. This will require a temporary bypass while crews do the necessary work. At this time we do not think closing of the road will be required. We will most likely use our Vactor Trucks to pump the manhole on the other side of the road and then transport the waste up the pipe.

Water crews located a large leak on Stadium Drive last week. This repair has certainly made a difference in our required water pumping. Crews have been focused for some time on locating any leaks and this one appears to have been significantly contributing to our loss. Their efforts have been instrumental in not only locating any leaks but their skill in repairing them is impressive. We still encourage not only our employees but all citizens to report any abnormal standing water they might notice.

Parks Department has been busy preparing for the start of soccer games on next week.

Baseball and Softball signups are ongoing and we hope to have another great year within the Parks Recreation programs.

As we move closer to summer we will be **evaluating streets for this year's overlay project**. If you have locations you would like us to look at please let us know.

Popeye's is now open! Whataburger will follow soon. Tee Time plans to open in early spring! Exciting times for Webb City staff as we work to make it all happen.

At this month's monthly meeting of the **Planning and Zoning Commission** they approved the two year renewal of the Urban Bicycle Clothing Company's Special Use Permit. They are located north of City Hall on W 2nd street. **Staff have discussed the idea of making a change in ordinance that would only require renewals of properly approved Special Use Permits if there develops an issue or complaint brought on by either adjacent property owners or City Administration**. We will be exploring this idea more in the future but staff feel this would

be more efficient and easier to track since we are sure there are many SUP's in place where renewals have not been completed.

City staff have met with engineers to discuss the completion of the Transportation Roadway Conditions Plan. We were able to utilize the results of the north side study in last year's overlay project and are hoping to receive council authorization to complete the south half of the city this summer.

The Caboose has been being reconstructed by the Webb City High School Vo-Tech Department. We were recently advised it is near completion and the Parks Department is now working to build a pad in front of the Depot and Farmers Market Kitchen for display. It is our hope this location will prevent some of the vandalism that was occurring back by the splash-Pad.

City staff have been working with traffic consultants to prepare an application for a State of Missouri Traffic Improvement Grant that we plan to fund a possible widening and roundabout project on East Street. This grant would fund on an 80%/20% cost share a total of \$2.5 million on construction costs. We will be seeking council approval for the application and support of the project in the near future.

Well #15 is now on line and operational. So far it looks to be one of our best producers as we continue to evaluate. Our Public Works staff should be recognized for bringing this project in approximately 40% under what the original estimates and budget had called for. We believe to date we have encumbered \$477,000 in expenses with a few outstanding invoices remaining but no where near the \$800,000 in the original estimate.

City staff have met with the owners of the property directly behind Flat Creek Grill and Sleep Inn. It is their desire to begin a commercial project on the land and have requested input from the city as to what we feel would fit best. Several options were discussed and an agreement was made with all to do our best to promote that site as any opportunities present themselves. We look forward to working with them **to spur further commercial ventures within Centennial Retail Park**.

Staff have been working with EPA and Cardinal Valley Habitat Trustees to fund a large concrete pad to be utilized in our bio-solid composting program. Currently we use the gravel area north of the plant to lay out our rows for composting and drying. A concrete pad would reduce wear and tear on our equipment and reduce any water seepage that occurs during the process. We have received word that this project has been approved for funding and we should be contacted in the near future with further details. This will be something we have been working on for many years and are excited to see it become even a possibility.



Actual Solid Waste Fund expenses for the 2022 – 2023 fiscal year were \$33,654 over the original budget of \$559,910.

WHEREAS, THE CITY IS AUTHORIZED TO AMEND AND REVISE THE ANNUAL BUDGET UNDER THE PROVISIONS OF SECTION 67.030 RSMO.

SECTION 1. PURSUANT TO SECTION 67.030 RSMO., THE CITY BUDGET FOR THE FISCAL YEAR 2022 - 2023 FOR THE CITY OF WEBB CITY, MISSOURI, IS HEREBY AMENDED AND REVISED; A COPY OF SAID REVISED BUDGET IS ATTACHED HERETO AND MADE A PART HEREOF. AN ORDINANCE amending Article III – Supplementary Regulations of Chapter 405 – Zoning Regulations of the Webb City Code, by enacting Section 405.185 – Cross-Access Easement Agreement.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WEBB CITY, MISSOURI, as follows:

WHEREAS, the City of Webb City, Missouri (the "City") is a third class city and political subdivision of the State of Missouri, organized and validly existing under and by virtue of the Constitution and laws of the State of Missouri; and

WHEREAS, the City desires to amend the Supplementary Regulations of Chapter 405 of the City Code to enact regulations to achieve direct and convenient vehicular access between properties.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEBB CITY, MISSOURI AS FOLLOWS:

SECTION 1: The City Council of Webb City, Missouri hereby amends Chapter 405 – Zoning Regulations of the Webb City Code by enacting Section 405.185 – Cross-Access Easement Agreement which shall hereafter read as follows:

Section 405.185 – Access Easement Agreement.

A. In order to guarantee proper, safe vehiclular cross-access between properties, provide for internal vehicular circulation between properties, and guarantee that the cross-access improvements will be maintained by current and future owners of property, Cross-Access Easement Agreements shall be required on all roadways deemed to have limited access, such as those maintained by the Missouri Departement of Transportation, and those determined to have limited access by the Director of Public Works. The Cross-Access Easement Agreements shall be recorded with the appropriate County Recorder of Deeds office and shall be binding upon, and inure to the benefit of future owners of the property, unless otherwise modified or amended.

B. Upon determination by the Director of Public Works that a Cross-Access Easement Agreement is required, no building permit will be issued until such time as the Cross-Access Easement Agreement has been completed and filed with the appropriate County Recorder of Deeds office.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval.
