Administrator's Report 08/26/24

Well #15 is finally up and running. Reports are that the well is performing at an extremely high level and we hope this will reduce the need for outside sourced water at least during the winter and spring times when yard watering is not so prevalent.

Public works has been busy striping the school crossings that we paved over prior to Mondays school start. Once that is complete we will be working to stripe streets that we can do with our machine and most likely contract out some of the longer stretches of street.

Limb Grinding is at an all-time high out at the treatment facility. We are continuing to work on a plan to offer permits to companies that wish to utilize the service but not impede on residents who wish to take their limbs out to the yard.

1st Street Water Line replacement Project has been ongoing. There have been many obstacles that were not anticipated such as gas lines in places we were not advised and service line issues but we continue to plug forward. We hope to have this project completed in the next few days to where we can at least remove the cones and bury the service lines. The addition of the Hydro dig on the Vactor truck has come in very useful during this project.

24/25 FY Budget preparations are in full swing. Each department has received their worksheets to begin making plans for next year. City staff have been advised capital purchases will be reviewed during the upcoming budget meetings and it is anticipated spending will be held to similar amounts as last year with the exception of adding the future personnel and expenses for the new Recreation Center in King Jack Park. We continue to evaluate job duties and areas we can streamline the position needed for operating this facility. There is also much work going into what will be offered as we open the facility. Emphasis will be on youth sport programs during the week and how we will make it available to public during inclement weather for exercise programs.

Park Staff are busy designing the amenities we plan to make a part of the **new upcoming Dog Park** that will be located at the old fenced in youth soccer field. We hope to have this area operational this fall.

Preparing for fall Flag Football and Soccer which begins September 9th is in full swing. Concession stands will be ready to go and we certainly appreciate all the work that goes into the planning of these activities behind the scenes.

Parks Department has already began the 2024 Polar Bear Express preparations. This work will move into high gear once the Fall Soccer and Flag Football seasons are under way.

The Webb City Chamber Paint the Town Red Parade and celebration will be held Wednesday September 25th. The parade will be at 6pm on Main Street and then following that we will again have the game and vendors in the area near the school off of Stadium Drive.

Previous Meetings

The **Paving** approved by council recently is complete. (or should be by time of meeting)

Public Works Water crew has been working hard to complete the **new water main on 1**st **street** prior to the start of school. If they can reach Washington Street before then the busses will not be interrupted. Our crews have not been slowed even by the extreme heat lately. This project has been on the list for many years and it is good to see it being completed. This will upgrade our fire protection ability in the entire area.

Webb City Route 66 Theatre will be hosting Senator Josh Hawley in front of the theater this Friday night from 5pm to 7pm. Main Street will be closed during this time as he is expected to kick off the start of his senatorial campaign.

Progress is still at a very fast pace on the new Recreation Facility and parking lot. All fill loads are complete and the actual foundation is being marked out and preparing for concrete.

Habitat staff have been working with the Joplin Trails Coalition to submit an application for a grant to fund some trails up to and north of the Waste Water Facility. The deadline was August 9th and we approved the application for funding basically because it does not result in any use of city funds. The JTC is agreeing to cover any matching funds required.

- 1. The grant would provide funding to place about 4000 feet of gravel walking/biking trail
- 2. Additional gravel would be placed behind the recycling area to provide additional parking. The parking area would have its own entrance off of Madison Rd, to keep it separate from the WWTP entrance which has the automatic gate.
- 3. The Trails Coalition will be the applicant and will handle the money.
- 4. City staff will help with some of the grading and construction. Some of the labor and equipment use will be counted towards the match amount.
- 5. If awarded Construction is planned to start in June.

City staff met this week with Webb City School Administration staff to discuss some planned projects we would like to get accomplished before school starts this fall. We agreed to assist in funding on a new sidewalk on land the school has purchased across the street from the highschool. The sidewalk has a couple areas of concern and we can utilize our budgeted 50-50 cost share program to help purchase materials up to \$5,000. There will also be some work at Main and Vine to try and smooth the sidewalk and ADA entrance.

The bridge from the Fire Department over to the Frisco Trail has been completely rebuilt and put in place. This was a group effort from several departments including the Parks, Public Works and Fire Department.

With the recent retirements and resignations in the Fire Department we have went from full staff to short staffed again. The Department has requested and granted authority to start an on call part time list similar to the Police Department Reserves. Chief Roughton reports he has already received interest from fire fighters serving in area departments who would like to fill some of those hours. We will continue to work to refill the positions as the FD has made plans to start their own training academy that would speed up the hiring and placement process.

Staff met with members of the Farmers Market for our monthly meeting and it was agreed to **install an ADA accessible doorway into the restroom at the Kitchen at the farmers Market**. We have received bids and the total cost will be \$4,200 and that will be split between the City and the Farmers Market. Farmers Market staff will be doing some maintenance and painting along the fascia of the pavilions and Parks staff will be planning to bring the picnic tables in this winter for some rehab.

Parks department reports the new LED lights at the tennis courts are installed and working great!

City staff are working with our VoIP phone provider to put together a **texting system for notifying late water payment accounts.** Currently we spend an enormous amount of time making courtesy calls each month. Our system has grown to the point where this is becoming too time consuming.

The filming of the documentary about the composting and waste water project is continuing. Crews have been given tours by Habitat and Plant staff for the last couple weeks. The grinding is continuing on the large amount of limbs as a result of the recent storms. We were forced to spend \$20,000 on a repair to the machine in order to keep it online. Recently the mulch that is being produced has been used in several of our parks thus reducing costs. Specifically it has been used to soften the playground surfaces and thus far has worked out really well.

The Caboose has been being reconstructed by the Webb City High School Vo-Tech Department. We were recently advised it is near completion and the Parks Department is now working to build a pad in front of the Depot and Farmers Market Kitchen for display. It is our hope this location will prevent some of the vandalism that was occurring back by the splash-Pad.

Mayor Ragsdale declared this session of council officially opened. Ref: Fire Department monthly report for July 2024.

The Webb City Fire Department responded to a total of 155 calls for service during the month. See attached sheet for breakdown information.

We are currently conducting annual business inspections for all licensed businesses within the city.

With the help of Public Works, the new walkway bridge for the trail at the FD has been installed. We have received several compliments from the public already.

Members of the department were involved with the rescue of a dog stuck on a ledge in a sink hole. They acted quickly and were able to rescue the dog without incident. I am proud of the way they handled the situation and came up with a safe plan. This reflects how their daily training pays off when needed.

We still have two positions to fill at the fire department. We are currently going through applications and interviewing candidates to find the right ones. In the meantime, we have added some part-time positions to help fill the voids to ensure adequate coverage for the citizens.

180 hours of department training and 10 hours of Public Relations have been conducted and we continue to assist the other departments in the city as needed.

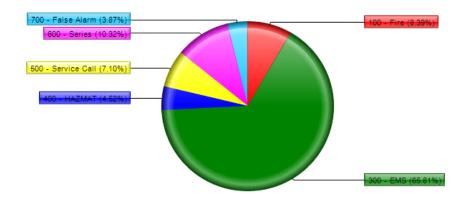

AN ORDINANCE TO ESTABLISH A PROCEDURE TO DISCLOSE POTENTIAL CONFLICTS OF INTEREST AND SUBSTANTIAL INTERESTS FOR CERTAIN OFFICIALS OF THE CITY OF WEBB CITY, MISSOURI

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEBB CITY, MISSOURI, AS FOLLOWS:

Section 1. <u>Declaration of Policy</u>. The proper operation of government requires that public officials and employees be independent, impartial and responsible to the people; that government decisions and policy be made in the proper channels of the governmental structure; that public office not be used for personal gain; and that the public have confidence in the integrity of its government. In recognition of these goals, there is hereby established a procedure for disclosure by certain officials and employees of private financial or other interests in matters affecting the city.

Section 2. Conflicts of Interest.

- a. All elected and appointed officials as well as employees of a political subdivision must comply with section 105.454 of Missouri Revised Statutes on conflicts of interest as well as any other state law governing official conduct.
- b. Any member of the governing body of a political subdivision who has a "substantial or private interest" in any measure, bill, order or ordinance proposed or pending before such governing body must disclose that interest to the secretary or clerk of such body and such disclosure shall be recorded in the appropriate journal of the governing body. Substantial or private interest is defined as ownership by the individual, his spouse, or his dependent children, whether singularly or collectively, directly or indirectly of: (1) 10% of more of any business entity; or (2) an interest having a value of \$10,000 or more; or (3) the receipt of a salary, gratuity, or other compensation or remuneration of \$5,000 or more, per year from any individual, partnership, organization, or association within any calendar year.
- Section 3. <u>Disclosure Reports.</u> Each elected official, candidate for elective office, the chief administrative officer, the chief purchasing officer, and the full-time general counsel shall disclose the following information by May 1, or the appropriate deadline as referenced in Section 105.487 RSMo., if any such transactions occurred during the previous calendar year:
- a. For such person, and all persons within the first degree of consanguinity or affinity of such person, the date and the identities of the parties to each transaction with a total value in excess of five hundred dollars, if any, that such person had with the political subdivision, other than compensation received as an employee or payment of any tax, fee or penalty due to the political subdivision, and other than transfers for no consideration to the political subdivision.
- b. The date and the identities of the parties to each transaction known to the person with a total value in excess of five hundred dollars, if any, that any business entity in which such person had a substantial interest, had with the political subdivision, other payment of any tax, fee or penalty due to the political subdivision or transactions involving payment for providing utility service to the political subdivision, and other than transfers for no consideration to the political subdivision.
- c. The chief administrative officer, chief purchasing officer, and candidates for either of these positions also shall disclose by May 1, or the appropriate deadline as referenced in Section 105.487 RSMo., the following information for the previous calendar year:
- 1. The name and address of each of the employers of such person from whom income of one thousand dollars or more was received during the year covered by the statement;
- 2. The name and address of each sole proprietorship that he owned; the name, address and the general nature of the business conducted of each general partnership and joint venture in which he was a partner or participant; the name and address of each partner or co-participant for each partnership or joint venture unless such names and addresses are filed by the partnership or joint venture with the secretary of state; the name, address and general nature of the business conducted of any closely held

corporation or limited partnership in which the person owned ten percent or more of any class of the outstanding stock or limited partnership units; and the name of any publicly traded corporation or limited partnership that is listed on a regulated stock exchange or automated quotation system in which the person owned two percent or more of any class of outstanding stock, limited partnership units or other equity interests;

3. The name and address of each corporation for which such a person served in the capacity of a director, officer or receiver.

Section 4. Filing of Reports.

- a. The financial interest statements shall be filed at the following times, but no person is required to file more than one financial interest statement in any calendar year.
- 1. Every person required to file a financial interest statement shall file the statement annually not later than May 1 and the statement shall cover the calendar year ending the immediately preceding December 31; provided that any member of the council may supplement the financial interest statement to report additional interests acquired after December 31 of the covered year until the date of filing of the financial interest statement.
- 2. Each person appointed to office shall file the statement within thirty days of such appointment or employment covering the calendar year ending the previous December 31;
- 3. Every candidate required to file a personal financial disclosure statement shall file no later than fourteen days after the close of filing at which the candidate seeks nomination or election or nomination by caucus. The time period of this statement shall cover the twelve months prior to the closing date of filing for candidacy.
- b. Financial disclosure reports giving the financial information required in Section 3 shall be filed with the local political subdivision and with the Missouri Ethics Commission. The reports shall be available for public inspection and copying during normal business hours.
- Section 5. <u>Filing of Ordinance</u>. A certified copy of this ordinance, adopted prior to September 15th shall be sent within ten days of its adoption to the Missouri Ethics Commission.
- Section 6. <u>Effective Date.</u> This ordinance shall be in full force and effect from and after the date of its passage and approval and shall remain in effect for two years from the date of passage.

That there is hereby levied a city tax for the revenue of said City for the tax year 2024 on each one hundred dollars of valuation of all taxable real property within the corporate limits of the City of Webb City, Missouri, according to the valuation as assessed for the year 2024, the same being the last assessment for county and state purposed, to be pro-rated as follows, to wit:

- A. A tax of \$ 0.3710 on each one hundred dollars valuation for the City of Webb City General Fund.
- B. A tax of \$ 0.2498 on each one hundred dollars valuation for the City of Webb City Library Fund.
- C. A tax of \$0.0841 on each one hundred dollars valuation for the City of Webb City Park Fund.

Section 2. This Ordinance shall be in full force and effect from and after its passage.

Contract Livescan as a Service for the Police Department August 26, 2024

SUBJECT:

Allow the police department to contract with Idemia to provide digital fingerprinting through Livescan as a Service.

BACKGROUND:

The police department uses a Livescan digital fingerprint device to collect fingerprints and mugshots from arrestees then electronically submit them to the Missouri State Highway Patrol – Criminal Justice Information Services Division. In the past the MSHP has provided a Livescan device and paid the annual maintenance contract for the device. Idemia is moving to a lease program that the MSHP will continue to pay for as long as the funding is available. The Livescan digital fingerprint device ensures that the fingerprints collected are identifiable by the MSHP and FBI's fingerprint systems.

RECOMMENDATION:

Allow the police department to contract with Idemia to provide digital fingerprinting through Livescan as a Service.

FISCAL IMPACT:

None at this time. The MSHP has provided the police department with Livescan devices and paid maintenance costs since 2006. However we may have to pay if the MSHP were to discontinue paying for the system.

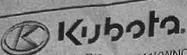
